#### SPECIFICATIONS AND CONDITIONS

Newnan-Coweta Art Association ("NCAA") members are eligible for entry. Membership information available at [www.newcaa.com](http://www.newcaa.com).

2D and 3D artwork completed **within the last four years** are eligible for entry into exhibit. Entries must be original in concept and design and suitable for viewing by all audiences. **"Prints" are not eligible for entry, including giclee prints.**

**All 2D artwork** must be professionally framed and wired for display, including paintings, photography, and **2D mixed media pieces. (No gallery wrap or saw-tooth hangers will be accepted.)** Maximum entry size: 4' W x 4' H.

Artists may not substitute another entry for an accepted entry or withdraw accepted entry. Title and price cannot be changed after submission.

Juror and/or committee reserve the right of refusal if accepted entry is not as represented in the photograph, or in the case of 2D artwork, does not meet framing requirements.

The Donald W. Nixon Centre for Performing and Visual Arts ("the Centre") is not responsible for any organization of the exhibit or reception. Comments/Questions should be directed to the exhibit committee.

Entries must remain in exhibit until Thursday, August 28, 2025.

#### METHOD OF ENTRY

Each artist may submit up to three entries. Photographs of entries **must be high resolution and printed on 5" x 7" glossy photographic paper.** Entries must be clearly labeled with an adhesive label on the back including the artist's name, title, size, medium, price, and entry identification (A, B, or C) and an arrow indicating top of entry. Avoid use of markers directly on back of photograph. Photographs will be returned with entries at Pick-Up on August 28, 2025.
