SPECIFICATIONS AND CONDITIONS

Only NCAA members in good standing are eligible for entry.

2D and 3D artwork will be considered for entry into the exhibit. Submitted artwork must be original in concept and design and suitable for viewing by any audience. Artwork must have been completed within the last four years.

"Prints" are not eligible for entry. Artwork must remain in the exhibit until Friday, June 26, 2020.

Artists may not substitute another work for an accepted work or withdraw accepted work. Title and price will not be changed after submission.

All entries must be professionally framed or displayed. (No white cardboard frames, etc.) Gallery wrap of less than 3/4 inches will not be accepted.

Juror and/or committee reserve the right of refusal if accepted artwork is not what was represented in the photograph, or in the case of 2D artwork, does not meet the framing requirements.

The Nixon Centre is not responsible for any organization of the show or reception. Comments are to be directed to the show committee.

METHOD OF ENTRY

Each artist may submit up to three works. Photographs of work must be printed on 4" x 6" glossy photographic paper. Artwork must be clearly labeled on the back. An adhesive label on the back should include the artist's name, title, artwork size, medium, price, and entry identification (A, B, or C). Include an arrow indicating the top of the artwork. Avoid the use of markers directly on the back of the photograph (the ink bleeds through the paper). Photographs will be returned to the artists on show closing day; Friday, June 26, 2020.
